#### Obtaining competitor proof of purchase



Question:	Answer:							
What forms of customer proof-of purchase (POP) are accepted?	The customer must provide a competitor license, support certificate or invoice (with sensitive commercial details redacted) but showing customer name, customer address, and competitor product name. Details of eligible products are provided on slide 4).							
Who is responsible for retaining customer proof of purchase?	The distributor is responsible for obtaining, and retaining an accepted form of proof of performance (as detailed above) and attaching to the quote stage, prior to an order being processed. Proof of Purchase is to be retained for a minimum period of <b>six (6) calendar months</b> after the promotional period ends (until 30 <sup>th</sup> April, 2018).							
What is the recommended process for obtaining customer proof of purchase?	The recommended approach is for the distributor to request accepted customer proof of purchase via the reseller (as detailed above) at the <u>quoting stage</u> , and in any event prior to an order being processed.							
What if an end customer refuses to provide a valid form of proof?	Failure to provide valid competitor proof of purchase (as detailed above) will result in a refusal to honour promotional pricing to the distributor.



Nearly half of data currently resides in physical systems



In the next 3 years, more data is expected to move to the cloud Data backup & recovery is a top use case for cloud







#### How do I process the promo order?

Using the same process you would to submit a Deal Approval ID (DAI) Code

What is the approved promo code to process the order with the promo discount? PM-000245 (12 months), PM-000257 (24 months), PM-000258 (36 months)

**Is competitor proof-of-purchase required?** Yes.

When is the last day to process a promo order? 31 October 2017.

Does the customer need to have active maintenance with the competitor? No.

#### What regions/countries is the offer available?

All regions/countries where Veritas does business at time of order acceptance.

#### Will order qualify for other discount or any rebate?

No. Only one discount is accepted. You are not able to use multiple codes in one order. If the promo discount is redeemed then it does not qualify for a Margin Builder discount (and vice versa).
